

# Little Angels Terms and Conditions

A deposit of £200 is taken once a place has been offered and accepted. This is payable upon entry. Children joining accessing funded places will only pay the deposit if accessing additional sessions. This deposit is fully refundable when your child moves to his/her next school at age 4, or if a terms notice is given; provided that the following conditions have been adhered to:

- A Terms notice is given or a terms fees are paid in lieu of notice before the removal of a child.
- Children leaving before the age of four will forfeit this deposit unless a terms notice is given.

## Emergency Treatment Permission Agreement

In the event of a medical emergency involving my child whilst in the care of Little Angels Nursery, or in the case of a serious accident requiring immediate medical attention for my child, I understand the Nursery Manager will contact me or emergency contact person as soon as possible. Where this is not possible, or where time is of the essence, I give my consent and authority to the staff of Little Angels Nursery to seek medical attention, advice or treatment for my child as appropriate.
